1. The said meeting was attended personally by 3 numbers of Secured Creditors of the Company entitled together to Rs. 16,47,54,467 value of debts representing 100% of the total value of debts of the Company. The quorum fixed by this Hon'ble Tribunal in respect of the meeting of the Secured Creditors was 2 (Two).
2. The Scheme of Merger and Amalgamation was read out and explained by me to the meeting and the questions submitted to the meeting was (i) whether the Secured Creditors of the Applicant Company agreed to the Scheme of Merger and Amalgamation between Reva Proteins Limited and the Applicant Company, submitted to the meeting and agreed thereto.
