Pursuant to above we had yesterday (03.04.2019) filed the certified true copy of the Merger Order before the Registrar of Companies along with Statutory Form INC-28.



Pursuant to the approval obtained from stakeholders for the Scheme of Merger which originally gained Observation Letter from BSE, both the Transferor and Transferee Companies filed joint Petition before National Company Law Tribunal, (NCLT) Chennai seeking an Order for merger of the Transferor Company with the Transferee Company.

After due process and compliance with Regulatory prescriptions, the NCLT has vide Order dated 27.03.2019 accorded approval for the Scheme of Merger, further ordering dissolution of the Transferor Company upon filing certified copy of the said Order with the Registrar of Companies, which action is pending for now.



Dear Sirs,

We wish to disclose for information of the investing public that one of our production units which is located at Kathikudam, Thrissur District, Kerala, where we manufacture the product Ossein, is facing production disruption initially due to the flooding in Kerala and subsequently due to shortage of river water on which our plant operations are dependent. The damage caused to equipment and material due to the flooding is covered under Insurance and our claim is under process.

We will be able to quantify the resultant loss of production only after there is clarity on water availability from the river.
